# **Terms and Conditions**

# I Believe, You Believe, We Believe Ltd Grants Program

**Effective Date:** 01/05/2025

These Terms and Conditions govern the awarding, use, and administration of grants offered by I Believe, You Believe, We Believe Ltd ("the Organization").

By applying for or accepting a grant, applicants and recipients agree to abide by these Terms and Conditions.

## 1. Purpose of the Grant

The Program aims to support children living with disadvantage by providing funding through the following programs:

- Sensory Stars
- Social Shakers

## 2. Eligibility Criteria

Applicants must meet the following conditions:

- Be the parent, guardian, or responsible adult acting on behalf of a child aged up to and including 17 years.
- The child must be experiencing disadvantage due to economic hardship and/or health issues, disability, or other social circumstances.
- Proof of eligibility will be required, including but not limited to:
  - Income verification (e.g., centrelink documentation)
  - Referral from a school, social worker, or other professional associated with supporting the child

#### 3. Grant Uses

Funds awarded must be used exclusively for one or more of the following Programs

- Learning Legends
- Terra Techs
- Sensory Stars
- Social Shakers

#### Funds **must not** be used for:

- General living expenses (e.g., rent, food, utilities)
- Non-educational or non-activity-related purchases
- Activities unrelated to the stated purpose of the Program

#### 4. Application Process

- Applications must be submitted via the official application form.
- Supporting referral by a Professional employed by a supporting organisation e.g. therapist.
- Incomplete or inaccurate applications may be rejected.
- Supporting documentation must be provided as requested.
- Submission of an application does not guarantee funding.

## 5. Awarding of Grants

- Grant amounts will vary depending on individual circumstances, up to a maximum value of \$1000.00
- Grants will be awarded based on availability of funds, eligibility, and demonstrated need.
- All decisions are at the sole discretion of the Organization and are final.

## 6. Payment and Reporting

• Grants may be paid directly to service providers or reimbursed to applicants upon submission of valid receipts.

- Grant recipients must agree to provide evidence of how the funds were used, including receipts, invoices, or progress reports if requested.
- Misuse of funds may require repayment and could disqualify applicants from future funding.

## 7. Monitoring and Evaluation

- Recipients may be asked to participate in a short evaluation process to help the Organization assess the impact of the funding.
- Testimonials, anonymized case studies, or feedback forms may be requested (participation is voluntary unless specified otherwise).

## 8. Publicity

• With prior consent, the Organization may use anonymized information about recipients for publicity and reporting purposes.

## 9. Privacy and Data Protection

- All personal information collected will be handled in accordance with I Believe, You Believe, We Believe Ltd's Privacy Policy and relevant data protection legislation.
- Data will be used solely for processing applications, administering grants, and program evaluation.

#### 10. Amendments and Termination

- The Organization reserves the right to amend these Terms and Conditions at any time or to terminate the Program without notice.
- Any changes will be communicated via the Organization's website or directly to affected applicants and recipients.

## 11. Governing Law

These Terms and Conditions shall be governed by and construed in accordance with Australian laws.
